PRIVACY POLICY

The personal information which are described in the following paragraphs are stored and used by MRICONS personnel in MRICONS premises or through secured VPN connections.

- A. **MRICONS** will not ask any personal data while you 're using the online post-processing platform except for the following data that will be used for <u>registering the</u> medical company in the platform:
 - o **Medical Company Title** or **First and Last Name** of the <u>medical company</u> employee which will use the post-processing platform.
 - o **Contact Email** of the <u>medical company</u>. If a generic email is not existing, it can be used instead a medical company employee email. The employee should be the one that will use the post-processing platform.
 - o **A Company Telephone Number** if MRICONS Personnel needs to contact the medical company employee.
 - Optionally, the First and Last Name of the director of MRI Department should be supplied to MRICONS in order to be included at the footer of the post - processing report, in case the medical company requests for.

The medical company employee can access through his profile all collected data and may correct them.

In order to delete a profile, the medical company authorized personnel should send an email to the privacy@mricons-support.eu and the company will comply within a maximum duration thirty (30) days.

You have the following rights in relation to your personal information maintained by MRICONS:

Your right of access

If you ask us, we'll confirm whether we're processing your personal information and, if so, provide you with a copy of that personal information (along with certain other details). You can also see directly via your profile link which information we're using.

Your right to correct information

If the personal information we hold about you is inaccurate or incomplete, you're entitled to have it corrected. You can also correct directly via your profile link your personal information.

Your right to "be forgotten"

You can ask us to remove your personal information in some circumstances such as where we no longer need it.

Your right to restrict information

- B. **MRICONS** logs the following parameters in the post-processing database, from an MRI Examination:
 - Patient Code: An unique code that is generated by the user during the identification process exclusively at the premises of the medical company
 - Medical Company
 - Post Processing Examination Types that has been requested by the user

MRICONS deletes the following parameters in the post processing database, after seven (7) days from the day that the examination was initially stored in Patient Code

MRICONS stores examination DICOM files and transmitted reports for at most seven (7) days after the day that the examination was uploaded by the user in database. **MRICONS** truncates the database log file every week and keeps the database backup for one week at most.

Data Collection and Privacy Policy (DCMROUTER)

"DICOM Router" (DCMROUTER) is a Software Application, deployed and used by medical centers, for anonymizing locally selected patient medical data (e.g. MRI examinations) and subsequently for securely transmitting those over a network to the company's (MRICONS) secured servers for post processing. The application is deployed on a workstation, inside site's internal network, and is constantly running at the OS level, ensuring its 24/7 operation. The end user can directly submit his medical data for processing directly from the medical device or PACS in use.

For ensuring Patient/Examination data **confidentiality and integrity**, a **de-identification process** has been implemented in DCMROUTER side.

For each dicom file arriving in DCMROUTER more than 240 DICOM Tags from its header are de-identified, adopting the guidelines provided by DICOM Supplement 142 Annex A1. This supplement is an international standard for de-identification of data in medical image files. The user may request more detailed information regarding the type of DICOM Tags that are been de-identified by sending an email to the following address: it_support@mricons-support.eu

Automatic collection of Information/Cookies.
